

**NOTICE OF PUBLIC HEARING
FINAL NOTICE OF INTENT TO APPLY
FOR 2022 CDBG-CV COMPETITIVE FUNDS
FOR THE BOROUGHS OF GARRETT & HOOVERSVILLE &
THE TOWNSHIP OF LOWER TURKEYFOOT
COUNTY OF SOMERSET**

In accordance with the rules and regulations under Title I of the Housing and Community Development Act of 1974, as amended, and the Pennsylvania Department of Community & Economic Development, Community Development Block Grant Program (CDBG) regulations, the Redevelopment Authority of Somerset County is conducting second and final public hearings for the purpose of advising residents of various municipalities of the proposed use of 2022 CDBG-CV Competitive Funds which are meant to prevent, prepare for, and respond to the spread of COVID-19.

The public hearing will be held on Monday, July 25, 2022, at 3:30 P.M. for the above-mentioned municipalities.

Proposed activities for each municipality are as follows:

BOROUGH OF GARRETT: Proposed use of funding in the amount of approximately \$2,000,000, will be to undertake streetscape type improvements along Walker Street including new sidewalks, curbs, pedestrian lighting, trail development and road reconstruction.

BOROUGH OF HOOVERSVILLE: Funds in the amount of approximately \$1,800,000, will be used to assist the Borough with water system improvements to provide, safe, sanitary drinking water to the Borough residents.

LOWER TURKEYFOOT TOWNSHIP: Funding in the amount of \$1,400,000, will be used to undertake water system improvements serving the Village of Draketown residents to provide safe, sanitary drinking water.

In addition to the above, delivery and administrative costs will be retained by the Redevelopment Authority for the management and administration of these projects. Details of these projects, as well as any other potential projects will be made available at the public hearing. Residents of these municipalities are invited to comment either in public or writing. Written comments may be submitted to the Redevelopment Authority of Somerset County, 300 N. Center Avenue, Suite 520, Somerset, PA 15501; or patty@somersetredevelopment.org, no later than 4:00 P.M. on July 30, 2022, in order to be included in these applications.

The General Public is also advised that the Somerset County Commissioners were presented with these applications for their approval and formal adoption at their regular meeting on July 19, 2022, at 10:30 A.M., at 300 N. Center Avenue, Suite 500, Somerset, PA 15501. The applications will be forwarded to the Department of Community and Economic Development, on or before August 1, 2022. The applications will be on file at the office of the Somerset County Commissioners and the Redevelopment Authority of Somerset County for public review.
